Course Description:

This one-day course is required for anyone wishing to obtain or renew a Drill Ground Instructor Certification issued by the Division of Fire Safety. The intent of this course is to ensure that instructors understand the safety issues and adopted NFPA Standards inherent in SCBA/Smokehouse and Live Burn firefighting training.

The students will be provided with a basic understanding of identifying and correcting unsafe situations as they occur and will review various safety concerns regarding drill ground instructional activities and student performance criteria.

CEU credit for the Drill Ground Instructor course will only count toward renewal of a Drill Ground Instructor certification, not a Fire Instructor II renewal or I.

Day 2: Wednesday, February 5, 2025

Mayday / FF Rescue HANDS ON TRAINING

The class is designed for Chief Officers, Company Officers, Firefighters, Dispatcher and EMS personnel.

Day 2 will take place at the **Atlantic County Fire Academy** and consist of multiple scenarios based on recent Maydays in the fire service. Maydays are dynamic events that occur regularly in the fire service. The HOT portion is designed for all ranks. Members will work on dealing with the stresses of a Mayday at the company level to the IC.

Chief Officers will be placed in command positions to manage not only fire ground operations but mayday operations. The IC will be given the tools to successfully manage the fireground. Fireground Command and Control skills will be discussed. Tactical worksheets and communications plans will be provided. **PPE/SCBA is not required for chief officers but is recommended. ALL MEMBERS OPERATING OUTSIDE OF THE IDLH ARE REQUIRED to wear helmets and eye protection.**

Company officers and firefighters will operate on the fire ground in real-world situations. Companies will perform engine, ladder, and RIT company tasks. The companies will practice the skills required to correctly announce a Mayday at an incident. The RIT teams will be deployed to locate, package, and remove a downed member. The company-level participants are required to have PPE/SCBA to operate within the IDLH. The scenarios will be as close to the real world as possible, including assistance from dispatch.

Trained dispatchers will be available to provide the necessary tools, including portable radios, frequencies, evacuation signals, and TIM.

Emergency Medical Personnel will operate outside of the IDLH to assist with Triage, Treatment, and Transport of rescued Firefighters. EMS personnel will be assigned to the EMS branch and will work to assist the IC with any emergency medical needs. Proper PPE is needed to participate. ***PLEASE NOTE:** No New Jersey EMS CUEs will be available for this course.

PRE-PLANNING AND FIRE SUPPRESSION OF BUILDINGS UNDER CONSTRUCTION & THE DANGERS OF VACANT DWELLING: CHALLENGES AND SOLUTIONS

Course Description:

The first half session of this course is designed to provide background and information to fire departments that may experience the construction of large area buildings in their community. Many fire departments have limited experience in the planning and response to these complex buildings. This requires a thorough understanding of the fire and building code provisions as well as the proper use of NFPA 241, Standard for Safeguarding Construction, Alteration, and Demolition Operations and NFPA 1620, Standard for Pre-Incident Planning. This program also discusses fire suppression concerns and considerations when a large area construction site experiences a fire.

PRE-PLANNING AND FIRE SUPPRESSION OF BUILDINGS UNDER CONSTRUCTION & THE DANGERS OF VACANT DWELLING: CHALLENGES AND SOLUTIONS

Learning Objectives:

- a. Identify risks & hazards on construction sites. Learn the leading causes of fires in structures under construction.
- b. Apply model codes and standards that pertain to safety precautions during construction and pre-incident planning.
- c. Identify the procedures and methods of pre-incident planning from the moment a building is contemplated.

The second half of the course will review two recent fires occurring in vacant dwellings that killed four firefighters. It will outline the many hazards and the pervasiveness of the vacant dwelling problem in urban centers. The presentation will discuss traditional ways authorities having jurisdiction have dealt with the vacant structure issue with specific focus on fire service solutions. And finally, offer “out of the box” ideas to mitigate the vacant dwelling problem.

Course Description:

The class will focus on the understanding and inspection of the fire protection systems in Big Box Retail and Warehouses. The class will include information from several NFPA Standards including the Classification of Occupancies, Commodity Classifications understanding the hydraulic data plate and the relationship to the fire code inspection. Included in the program will be the principles of and code requirements for Early Suppression Fast Response sprinkler systems. An overview of the storage related chapters and the requirements for idle pallet storage from NFPA 13 will be presented. The requirements of NFPA 25 for the inspection, testing and maintenance of building fire pumps will be presented. Case studies and a review of violations discovered in Big Box and Warehouse Occupancies are included in the class.
